

Why to use it

IMPREZO pinefresh is an ideal damp mopping solution for all surfaces. Economical maintenance for polished floors which will not remove or dull polish at recommended dilution.

Perfect for spray cleaning. Removes dirt and heel marks with ease.

Where to use it

For regular cleaning and maintenance of linoleum, P.V.C., rubber, sealed cork, sealed wood and thermoplastic floors.

How to use it

For general mopping dilute IMPREZO pinefresh 1 part to 100 parts hot water. Mop, allow to dry, burnish if required to improve shine.

For spray burnishing dilute 1 part to 50 parts water. Spray lightly ahead of machine fitted with a nylon pad and immediately polish to a shine.

N.B. For maximum floor life we would recommend that floors are polished with IMPREZO supasheen prior to regular maintenance with IMPREZO pinefresh.
